CONDITION OF ISSUE - This permit is issued on the condition that construction will not commence under the power or communication lines or over any underground service including but not limited to gas, sewer, water or power lines without prior approval of the authority having jurisdiction.

This permit does not include permission to dig, tunnel or bore into or under any part of a street, nor to occupy or obstruct any street sidewalk or other municipal property. To obtain permission to occupy the street or sidewalk during construction, present this permit at the office of the Municipal Engineer. The owner is responsible for the proper setting of grades for the structure.

The permit is granted on the express condition of full compliance with all provisions of the Building Code Act, R.S.O. 1990, C.B. 13, and regulations made thereunder and of any By-law or any amendment thereto of the municipality which in part or in whole regulates the structural requirements, the erection, alteration, locations, use etc., of buildings - unless otherwise specifically so provided for and approved in writing by the Building Inspector. This permit is subject to revocation pursuant to subsection 8 (10) of the Building Code Act.
